

## **PROHIBITED AND RESTRICTED COMMODITIES**

### **PROHIBITED COMMODITIES**

- Animals, fish, birds (live)
- Human remains or ashes
- Bullion (of any precious metal)
- Cash (current legal tender) (bank notes, currency notes and coins)
- Loose precious stones
- Complete firearms, ammunition, explosives / explosive devices
- Imitation or replica firearms, ammunition, explosives / explosive devices
- Illegal goods

### **RESTRICTED COMMODITIES**

- Antiques and works of art
- Banderols/tax stickers
- Cigarettes
- Dangerous goods
- Firearms parts
- Furs and ivory
- Jewellery, watches, precious metals (other than bullion)
- Negotiable instruments in bearer form (whether cash-like or not)
- Toy guns, air guns

### **Notes**

PROHIBITED: Prohibited commodities should, without exception, be refused for carriage regardless of value, business potential or who the customer is.

RESTRICTED: Restricted commodities may be acceptable for carriage where there is a clear business value to be gained from accepting the commodity. Acceptance of these items is likely to require special operational and/or security procedures, specific contractual wording or additional costs for the customer. A business case should clearly document a specific requirement for the carriage of a restricted commodity along with operational, security and contractual details.

## PROHIBITED COMMODITIES

- Dangerous Goods -any solid, liquid, or gas that can harm people, other living organisms, property, or the environment. Dangerous goods include materials that are radioactive, flammable, explosive or corrosive, oxidizers or asphyxiates, biohazardous, toxic, pathogen or allergen substances and organisms or any items classified under the IATA Regulations. (Please refer here for a list of IATA Dangerous Goods Classes).Contraband or illegal items –any items that may be deemed to be illegal by the government of the country of origin or destination.
- Any article bearing the imprint or reproduction of any currency note, bank note, or coin which are current or have at any time been issued or current in any country.
- Any emblem or device in circumstances which raise a reasonable presumption that such emblem or device was intended or was likely to be used in a manner prejudicial to the interest of Malaysia or to promote or foster a purpose prejudicial to or incompatible with peace, welfare or good order in Malaysia.
- Cloth bearing the imprint or reproduction of any verses of the Quran.
- Intoxicating liquors containing any lead or compound of lead or more than 3.46 milligrams per litre, whether in the form of copper or any compound of copper.
- Pirated CDs, VCDs and DVDs.
- Bullion (of any previous metal), jewellery and objects construed of previous metals and/ or stones, loose previous stones.
- Broadcast receivers capable of receiving radio communication within the ranges (68-87) MHz and (108-174) MHz except those designed to receive meteorological broadcasts at spot frequencies (except those for the use of the telecommunication authority).
- Any medical samples.
- Any perishable items (2nd Phase)
- Any liquids (declaration to be verified)
- Bird Nest (2nd Phase))
- Toy Guns
- Firearms, firearms part, weapons, explosive devices or ammunition.
- Any Item which could be used as weapon
- Human remains or ashes
- Live Animal, Fish, Bird, Insect, Larva, Pupae, etc.
- Plant
- Tobacco (2nd Phase)
- Furs and ivory
- Antique Goods
- Negotiable item-Bearer Form
- Negotiable item is in bearer form when it is readily
- Transferable or payable to bearer. (2nd Phase)
  - Cash
  - Cheques (bearer form)
  - Activated credit card

- Telephone SIM ( both activated and non-activated)
- Telephone prepaid card (activated)
- Negotiable item –Non-Bearer Form
  - Banker’s draft
  - Bonds
  - Shares
  - Stock certificates
  - Non-activated credit card
  - Tickets (blank stock)

### **RESTRICTED COMMODITIES**

- Any item list in this category can be acceptable for carriage if the value not exceed the maximum acceptable value per consignment note.

#### **Restricted Items List**

- Watches
  - Value per shipment must not exceed USD300.
- Costume jewellery
  - Value per shipment must not exceed USD100.

### **CONTRABAND**

- Weapons/ Firearms/ Dangerous Weapons/ Imitation Firearms
- Controlled chemical substances
